

## GENERAL REGULATIONS FOR VISITORS OF VINITALY, ENOLITECH AND SOL

### 1. INTRODUCTION

Veronafiere has adopted the following General Regulations for Visitors/Operators in order to define appropriate rules of behavior inside the Verona Exhibition Center. These Regulations are applicable to all visitors attending the Vinitaly, Enolitech and SOL events organised by Veronafiere.

Vinitaly, Enolitech and SOL are scheduled 14-17 April 2024 in the Veronafiere Exhibition Center.

The event timetable is from Sunday to Tuesday 9:30 – 18:00 and on Wednesday 9:30 – 16:30. Access is allowed until 17:00 from Sunday to Tuesday and until 14:30 on Wednesday.

With the vision and acceptance of the present Regulations, the visitor undertakes to comply with the rules contained and to follow an appropriate behavior in compliance with the public safety laws.

### 2. CONDITIONS OF ACCESS TO THE EVENT AND SERVICES

Access is allowed to the following categories in compliance with the days dedicated to them:

Large-Scale Distribution	restaurants	wine bars	producers of olive oil and wine
wholesalers import-export	hotels	sommeliers	the trade press
food retailers	catering	wine technicians	authorities
bars	wine stores	wine technology producers	institutions

Specifically, operators who do not have a direct and active role in purchasing ("Sommelier for passion" and "My company does not exhibit at Vinitaly") will be able to choose to visit the exhibition only on Sunday and Wednesday.

Persons under 18 years of age will not be admitted even if accompanied.

Entrance to the Event is on payment and Trade Only. The price of the ticket equals the one written on the ticket itself.

Visitors can obtain the title of entrance to exhibitions:

- through the online validation of an invitation code,
- buying a ticket online.

The validation of invitation codes or the purchase of tickets can only be made after mandatory online registration on the events' websites.

The visitor must:

- Fill the registration form, providing the personal data requested and ensure that they are complete and truthful. **Tax code and the data required for the control** are required in order to guarantee the adulthood of the visitors of the event; foreign visitor must have a copy of a document with photograph such as passport, identity card or driving license;
- Control carefully your personal data to insure they are true and correct;
- Take vision of privacy policy;
- Accept the Regulations by ticking the appropriate flag;
- The ticket will be sent to the designated e-mail address using a print@home service;
  - o enter the fair it is necessary to print the ticket or download it through the app.

All visitors, at the time of registration, must provide true information about their identity and activity. In the event of misrepresentation, persons concerned may be liable to legal action. Entrance tickets are personal and the tickets are non-transferable. If visitors are found in possession of entrance tickets made out to other persons, Veronafiere reserves the right to withdraw them and demand that said visitors leave the Exhibition Center.

**All visitors can purchase and register in their own names n. 04 total entrance tickets valid for a single (01) entry on each exhibition day.**

Visitors who redeem an exhibitor invitation coupon give their consent for their personal data (name / surname / city / province / country) to be shared with the exhibitor who sent the invitation.

The entrance ticket to the Exhibition Center can also be used as a "business card" to be shown to exhibitors; they will be able to use the event APP to scan the QR Code printed on the ticket and thereby collect visitor ID and contact data.

## 3. PROHIBITED CONDUCT INSIDE THE EXHIBITION CENTER

### General dispositions

All visitors must follow an appropriate behavior in compliance with the public safety laws, in order not to represent a threat to the safety during the Exhibition. They also should not interrupt, disturb or try to prevent the smooth and orderly conduct of the Exhibition. All visitors, moreover, are required to observe a careful behavior during the Exhibition, and to listen to both announcements and rules of conduct displayed inside the Exhibition Center.

### Introduction of dangerous items inside the Exhibition Center

It is strictly forbidden to introduce any dangerous item, which could cause harm to anyone involved in the fair, inside the Exhibition Center.

### Sale of products inside the Exhibition Center

It is strictly prohibited the marketing of the products inside the Exhibition Center. In case of violation, Veronafiere will have the right to require the intervention of Public Security authorities, which will take all the appropriate measures against the responsible of the violation. Veronafiere will have the right to withdraw the entry ticket.

### Distribution of advertising and promotional materials inside the Exhibition Center

Distribution of advertising and promotional materials inside the Exhibition Center is prohibited. In case of violation at the visitor will be withdraw the entry ticket.

### Childrens / Underages

During Vinitaly, Enolitech and SOL events, underages are not allowed inside the Exhibition Center.

### Security

All visitors, in order to access the Exhibition, must accept any security inspection or control, including the use of metal detectors, before and during the visit. They could also be invited to show the content of bags, backpacks or any other luggage.

## 4. RESPONSIBILITY

Veronafiere declines any and all liability for damage to things and/or people inside the Exhibition Center unless such harmful episodes are attributable to the exclusive responsibility of Veronafiere. Veronafiere also declines any and all liability for any consequence imputable to negligence or reckless behavior. Any incident involving visitors must be communicated to the security service in order to make any necessary verification. Any lack of communication, however, releases Veronafiere of any liability towards the visitor. Veronafiere, moreover, declines any and all liability for every unpredictable or indirect damage such as lost profits, lost occasions, loss of income, clients, data or any and all financial or commercial damage or problem or intangible damage.

Veronafiere declines any and all liability for false and/or misleading information conveyed through promotional material distributed by third parties without the authorisation of Veronafiere's Directorate General.

Furthermore, all visitors give consent to any photograph or filming during the Fair. Veronafiere, as well as any authorized third party, is allowed to publish or broadcast any above-noted material without any compensation for the visitor.

## 5. CANCELLATION AND/OR RESCHEDULE OF THE EVENTS

Veronafiere reserves the right to cancel and/or reschedule the Events listed in its calendar.

Refunds of entrance tickets will only be made if Veronafiere cancels and/or reschedules the Vinitaly, Enolitech and SOL events and in accordance with the procedures and times defined by Veronafiere itself.

## 6. CHANGE OF THE GENERAL VISITOR REGULATIONS

Veronafiere reserves the right to modify the General Visitor Regulations at any time. An up-to-date version of the Regulations will be published on the websites of the Vinitaly, Enolitech and SOL events and will come into effect immediately.
